

The International Journal of Esthetic Dentistry (IJED) is a quarterly journal that publishes peer-reviewed articles of the highest quality regarding all aspects of esthetic dentistry, with the goal of enhancing the international exchange of knowledge in this multidisciplinary field. Manuscripts presenting case reports (of failures as well as successes), treatment planning sessions, innovations in methods or products, and clinical and technical applications of esthetic dentistry are invited. In addition, guest editorials may be solicited periodically by the editorial board.

Submission Instructions. Manuscripts should be submitted online at www.manuscriptmanager.net/ijed. Manuscript texts should be uploaded as a Word file with tables and figures included at the end of the document. No paper version is required. Online submissions are automatically uploaded into the reviewer assignment schedule and are therefore processed immediately. Resubmitted manuscripts should also be submitted in the above manner. Please note that supplying electronic versions of tables and figures upon resubmission will expedite publication if the manuscript is accepted.

Review/Editing of Manuscripts. Manuscripts will be reviewed by the editors and at least two reviewers with expertise within the scope of the manuscript. The publisher reserves the right to edit accepted manuscripts to fit the available space and to ensure conciseness, clarity, and stylistic consistency, subject to the final approval of the author/s.

Adherence to Guidelines. Manuscripts that are not prepared in accordance with these guidelines will be returned to the author/s before review.

Manuscript Preparation.

- **Manuscript format.** Text should be typed double-spaced with 1-inch margins all around. All pages should be numbered. The first page should include the title of the manuscript (descriptive but as concise as possible) and the names, degrees, titles, professional affiliations, and full addresses of all authors. Telephone and fax numbers as well as an email address must also be provided for the corresponding author, who will be assumed to be the first-listed author unless otherwise stated.
- **Title.** Maximum of 12 words. Adding a subtitle is possible.
- **Authors.** The number of authors is limited to 8. All listed authors should have contributed to the manuscript substantially and have agreed to the final submitted version.
- **Keywords.** One to six keywords should be provided, taken from the US National Library of Medicine's MeSH (Medical Subject Headings) controlled vocabulary.
- **Abstract.** A 150- to 250-word abstract must be included.
- **Abbreviations.** The full term for which an abbreviation stands should precede its first use in the text unless it is a standard unit of measurement.
- **Trade names.** Generic terms are to be used whenever possible, but when trade names are used, the name and address (city and country) of the manufacturer should be provided parenthetically at first mention.
- **Figures.** Maximum of 25 figures (not figure compositions!).
- **Legends.** Figure legends should be typed (double-spaced) as a group on a separate page and included in the manuscript file.
- **Tables.** Each table should be logically organized, typed as a separate page in the manuscript, and numbered consecutively. The title and footnotes should be typed on the same page as the table.
- **References.** Maximum of 30 references. References should be typed on a separate page and included in the manuscript. Cite all references numerically, in order of appearance in the text, and place the reference number in the correct place in the text in parenthesis. Limit references to those specifically cited in the text. Provide complete information for each reference, including names of all authors (if there are more than six authors, *cite three only, followed by et al.*). Avoid using abstracts as references. Use the following exact style for the reference list:

Journals

1. Nevins M, Camelo M, De Paoli S, et al. A study of the fate of the buccal wall of extraction sockets of teeth with prominent roots. *Int J Periodontics Restorative Dent* 2006;1:19–29.

Books

1. Demirel K, Gürel G. Periodontal considerations in esthetic treatment planning. In: Gürel G (ed). *The Science and Art of Porcelain Laminate Veneers*. London: Quintessence, 2003:207–230.

Do not include unpublished data or personal communications in the reference list; cite such references parenthetically in the text and include a date.

- **Acknowledgments.** These should include people who have made substantial contributions to the study/article; sources of financial support for conducting the research and/or preparation of the article; organization names and grant numbers in the case of specific grants or other financial support having been received for the study/article.
- **Disclaimer.** In order to move into the peer review stage, each article must include a disclaimer acknowledging any conflicts of interest of any of the authors, or a statement claiming that the authors have no conflicts of interest in relation to the study.
- **Methodological and reporting requirements.** Documented proof of ethical approval by an independent Institutional Review Board must be provided for all preclinical and clinical studies, with the exception of case reports. Clearly indicate in a separate document that the study obtained appropriate approval, including the name of the ethics committee/s or institutional review board/s and the number/ID of the approval/s. For human studies, also add a statement that participants provided written informed consent before participating in the study, and that the study was conducted in accordance with the Declaration of Helsinki ethical principles of 1964, as revised in 2013. Authors are encouraged to use the ID-COSM (Implant Dentistry Core Outcome Set and Measurement) international consensus report for planning, conducting, and reporting clinical studies in the field of implant dentistry.
- **Changes in authorship.** After a manuscript has been accepted, any request for changes in authorship (order, deletions, or additions) must be made by the corresponding author to the managing editor. The reason for the change should be given, with written confirmation of the change by all contributing authors, including any author who is being added or deleted.

IJED Espresso. Double-page spread, approximately 200 words structured as: Title (maximum 45 characters, including spaces), Case briefing, Treatment plan, Conclusions, maximum 8 to 10 numbered figures (figure numbers must be mentioned in the text), no references, no figure legends, mention specialists involved (include photographs and email addresses).

The Last Page. One page, maximum 150 words, Title ("How to manage ...") plus a maximum of 35 characters, including spaces), maximum 8 to 10 numbered figures (figure numbers must be mentioned in the text), no references, no figure legends, name/s of author/s and email address/es.

Social Media. Only one photograph, figure legend, camera details, photographer's name, email address, and Instagram/Facebook identification.

Illustrations. High-resolution image files must be sent upon manuscript acceptance to Quintessenz Verlags-GmbH. Please consider the following points:

- Only send unprocessed original images, with a width of 2000 pixels or more (equivalent to about 8 megapixels).
- Please send us the untrimmed original data so as not to restrict the scope for an esthetically pleasing print layout. The image sections from authors' manuscripts will be used as a guide.
- Image sections or arrangements edited or designed for other media are not accepted.
- Graphics (bar charts, diagrams, drawings) should preferably be created in graphics programmes such as Adobe Illustrator and saved as ai, pdf, svg or eps files.

Videos as Additional Material to Supplement Articles. In principle, videos can be submitted with an article as supplementary or additional material (maximum video duration: 2 min). These must be included with the submission as they will only be published after acceptance by the reviewers. In general, the video must present an additional aspect that is not covered by the content of the article. In order for it to be considered, the video must meet the following requirements:

- Video format: MP4
- Video codec: H.264
- Video resolution: Full HD (1920 × 1080 pixels), but at least HD (1280 × 720 pixels)
- Audio codec: AAC or MP3 with at least 128 kbit
- Additional: Preview image from the video (original size) with figure legend

Mandatory Submission and Copyright Form. This form, signed by all the authors, must be sent to the editorial office before the manuscript review process can begin. The form is available for downloading at: <https://www.quintessence-publishing.com/deu/de/journal/international-journal-of-esthetic-dentistry-en#downloads>.

Permissions and Waivers.

- The permission of the author/s and the publisher must be obtained for the direct use of material (text, photographs, drawings) under copyright that does not belong to the author/s. Legends and tables should contain proper credit lines (full citation of the source and the words "Reprinted with permission").
- In the case of photographs of patients or other persons, the consent of the patient or the legal representative must be obtained for the publication of the photographs on- and offline for the purposes of publication, dissemination, and making available to the public in publications of Quintessenz Verlags-GmbH. A consent form is available for downloading at: http://www.quintessenz.de/downloads/photograph_permission.pdf.
- In the event of infringement of third-party rights (copyrights, personal rights, data protection rights, etc), the author/s undertake to indemnify the publisher against all third-party claims.
- Submit all letters of permission and waivers with the manuscript.

Complimentary Copies. The corresponding author will receive a free-of-charge PDF document of the published article as an electronic sample copy. Printed copies of the complete journal will be sent on request.

Statement Regarding Online Preprints and Social Media. Please note that online preprints of manuscripts submitted to the IJED are not permitted, regardless of the online platform. Thus, any manuscripts pre-printed online prior to submission will be rejected by the IJED.

Excessive social media posts of patient images prior to the publication of an article in the IJED should also be avoided by the authors.

Artificial Intelligence (AI) Use Statement. Authors must disclose whether generative or nongenerative AI-assisted technologies (eg, large language models or image creators/editors) were used to produce part of the submitted work. They should do so by including, in the Materials and Methods or Acknowledgments sections, detailed information regarding the specific use of these technologies during the production of the work (eg, as a methodological component of the study or as writing aids) as well as the name of the AI tools employed, including their version. Please note that clinical images generated by AI are strictly forbidden. The IJED editors may decide to reject a manuscript if the use of AI-assisted technologies is considered inappropriate. Since the authors are fully responsible for the accuracy, integrity, and originality of the submitted work, AI-assisted technologies cannot be listed as authors or coauthors. Likewise, to avoid the introduction of bias in the literature, sources created by these technologies cannot be cited. Additionally, authors who employ AI tools to assist them in their writing are expected to carefully and responsibly revise the generated language to prevent the spread of inaccurate or false information.

Peer reviewers may not use AI-assisted technologies in generating or writing their reports because the reviewers are accountable for the accuracy of the opinions expressed in their reports. The use of AI-assisted technologies could therefore breach the integrity and confidentiality of the review process, which is based on mutual trust between editors, authors, and reviewers.

As it is likely that further developments in this field will occur rapidly, policies and guidelines related to the use of AI-assisted technologies will be regularly reviewed and changes made, if necessary.
